



Trilogy Security and Preparedness Committee (TSPC)

Report to the WMA Board

February 23, 2019

Overview

The committee continues to develop community awareness of security and preparedness issues within Trilogy.

Specific Events and Activities

1. An "Introduction to Home Security" briefing was presented to residents in January and again in February. Attendance was high at both presentations and many residents expressed appreciation for the committee's efforts.
2. A "Security Vendor Fair" was sponsored by the committee on February 20th. Vendors at the fair included Best Buy, Home Depot, Sentinel Security Solutions, Smith's Alarms and Electronics, ADT and the SLO Sheriff's Department Crime Prevention Unit. Over 60 residents attended the fair.
3. The committee worked with the social media website "Nextdoor" and got the "Trilogy" community boundaries realigned so that they now match the physical boundaries of Trilogy at Monarch Dunes. This eliminated the problem that when residents in surrounding communities posted on the site they were identified as being Trilogy residents when, in fact, they were not. This caused unnecessary concern among Trilogy residents when crime related discussions were posted for areas outside Trilogy. This change also allowed the TSPC to post messages specific to Trilogy residents and be confident that only Trilogy residents would see the posts.
4. The committee met with Rob Miller (WMWCo GM) regarding the inclusion of enhanced physical security and lighting in the water storage tank area on Kingston as well as the water treatment area south of the business park. We have also made suggestions for possible accommodation in the water storage area for a future emergency operations center related to the preparedness activities we are pursuing.
5. Steve Dippell, our law enforcement liaison, has accepted the position of Vice-Chair for Security.
6. Susan Huls has resigned from the position of Vice-Chair for Preparedness due to personal reasons and we are seeking a replacement.
7. Current initiatives include the following:
 - Neighborhood Watch
 - Snap and Send (Interest survey)
 - Email registration for TSPC notices and alerts. Communication with Trilogy residents continues to be a challenge since no mechanism is available to push TSPC communications to all Trilogy residents. Use of the WMA/CCMA email database would be the easiest solution, but only limited use of this database is currently available to the committee.
